Risk of Antibody Dependent Enhancement

causing more severe Covid-19 illness on exposure to virus post-vaccination

MHRA 09 Dec 2020: Any person history of anaphylaxis to ■, medicine, or food should not receive Pfizer/BioNtech■

A 2nd dose should not be given to
anyone who has experienced anaphylaxis.

Any patient w/ a history or strong family history of allergies or autoimmune conditions may choose to refuse a CV-19■.

Doctors working with CFS/ME patients already advise them to avoid
vaccination as this may trigger a relapse.

Patient's individual risk from Covid-19 MUST be discussed – IFR <0.05% for <70yrs to weigh up against risk from ■

Patient expectation of vaccine benefit i.e.
reducing risk of severe illness, hospitalisation and preventing infection with and transmission of SARS-Cov-2

Make patient aware that current trials are not designed to show if CV-19■ will reduce their risk of hospitalisation or death or
will prevent infection and transmission of virus as may affect risk v benefit profile

Patients MUST be made aware of the full list of vaccine ingredients

Ethical/religious considerations e.g. animal products -vegetarianism/veganism, WI-38 human diploid cells (aborted fetus

source) - pro-life/religious belief

You have the right to see full list of adverse reactions in insert.

Ex: Common side-effects include chills, fever, myalgia, fatigue, arthralgia, headache, and pain at the injection site.

A reaction to the 1st dose may increase risk of a major reaction to a 2nd dose.

Before a 2nd dose, the patient must be asked about their reaction to the 1st dose.

Moderna vaccine -100% of high-dose participants report systemic side effects after second dose, some severe.
