AFTER a surfeit of scandals relating to fake godmans, yet another *ashram* from Coimbatore is in the limelight with Jaggi Vasudev, alias Jagadeesh of Isha Yoga Ashram, at Poondi near here, being charged with the murder of his wife Viji alias Vijayakumari.

According to the police, T.S. Ganganna of Bangalore (Viji's father) had complained to the Bangalore City Police suspecting foul play in the death of his daughter Viji, who was married to Jaggi.

The complainant said that, his daughter had left him last on June 15, '96 and that he had received a message on January 23, '97 from Jaggi, saying that Viji was no more.

Ganganna has also reportedly said that despite requests, Jaggi had hurriedly cremated the body on January 24, even before he

could rush from Bangalore.

He has also said that burning the body was not the custom in their community. Jaggi had seemingly chosen this method for disposing the mortal remains of Viji.

Ganganna suspects Jaggi of having done Viji to death, to facilitate his illicit relationship with another inmate of the *Ashram*. Based on Ganganna's complaint to the Bangalore City Police, a case was registered.

The Bangalore City police have subsequently transferred the case to the Coimbatore Rural Police, under whose jurisdiction, the *Ashram* falls. They have registered a case against Jaggi.

Meanwhile, a team of police personnel have visited the premises of Isha Ashram at Poondi and interrogated the people there.

Godman Jaggi is in the USA and further investigations are on in the case.

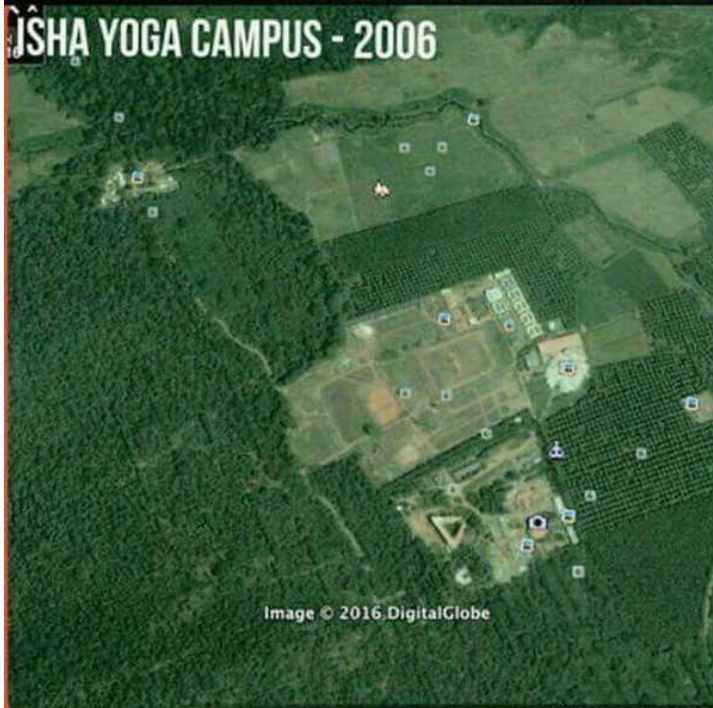

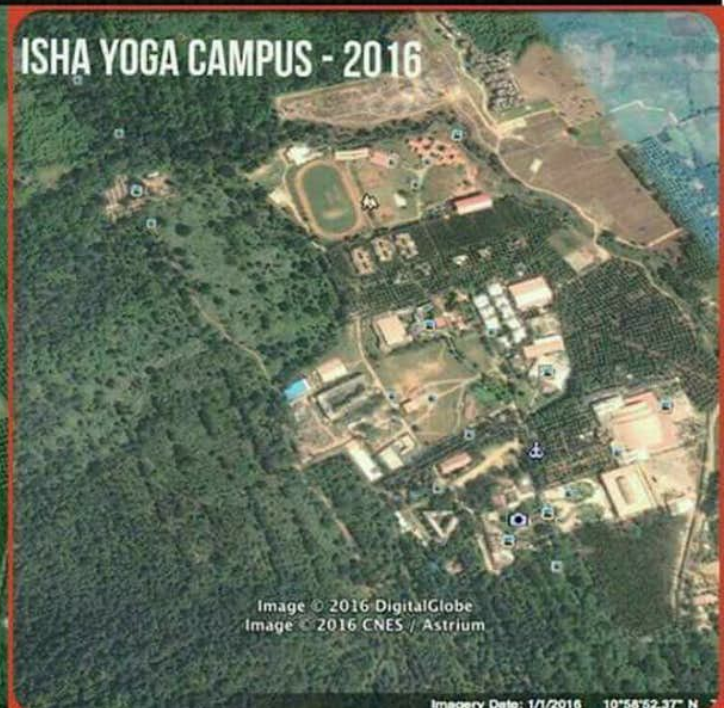

Isha Buildings Have No Govt Nod

Chennai: The Isha Foundation, founded by Sadhguru Jaggi Vasudev aka Jagadeesan, has not obtained any clearance from the district Collector and the Deputy Director of Town and Country Planning for the buildings it constructed on the foothills of Velliangiri near Coimbatore.

The Deputy Director of Town and Country Planning, Coimbatore region, in a counter affidavit filed in the Madras High Court on Tuesday, said the Foundation has already constructed 62 buildings and is in the process of

erecting another 15 buildings. "Hence, 'lock and seal and demolition' notice has been issued to the Foundation in December 2012," the counter said.

Express was the first to report on these illegal constructions. According to the counter affidavit, the Isha Foundation had submitted proposals for construction of 12 buildings in July, 2011, but it was returned with a direction to resubmit in full shape in February 2012.

In September same year, the Foundation resubmitted the proposal and during inspection by the officials in October, it was found that

the construction has already begun and the building plan was not tallying with the actual at the site.

The Foundation was directed to resubmit the plan as per the construction made at the site along with requisite no objection certificates from the Forest, PWD, District Collector and others.

As the construction was not stopped, 'stop work' notice was issued on November 5, 2011. Subsequently, sealing notice was issued on December 24, 2012, the counter said and the proposals were returned as they were not in full shape again in January this year.
