**When I dug into Mitch McConnell's election results so many people said**

**"Now do Lindsey Graham"**

**I get it.**

**Lindsey got 672,941 votes in 2014.**

**In 2020 he DOUBLED his votes to 1,369,137.**

**Really■**

**So I wanted to share more questions on Kentucky & some from South Carolina**

### **THREAD■**

I initially was able to spot patterns in Kentucky since counties used different voting systems & results were inconsistent. Counties with unusual big wins for Mitch all used ES&S voting machines

But it's harder to detect patterns in South Carolina since they use ES&S state-wide.

Recently while revisiting Kentucky's data it led me down a path to South Carolina.

First I saw:

■2,134,996 Kentuckians voted for the President

and

■2,134,446 voted for the Senate

A difference of exactly 550?

That number felt tiny■

So then I reviewed Kentucky's historic data.

In past elections, 20,000+ folks voted for President but left down-ballot races blank. That changed in 2020's election:

2008: 25,687 (1.41%)  
2016: 20,684 (1.07%)  
2020: 550 (0.03%)

This number still stuck out so I went back further...before KY's shift to electronic voting■

The change in the numbers since Kentucky shifted to electronic voting machines is stunning.

■71,498 left down-ballot races blank in 2004 (3.98%)

■Only 550 left down-ballot races blank in 2020 (0.03%)

Wow?!?■

So I compared KY to other states & that's how SC jumped out at me.

South Carolina data historically showed many folks voted for President but not down-ballot:

2008: 49,538 (2.58%)  
2016: 53,134 (2.53%)  
2020: -1,775 (-0.07%)

Suddenly it all flipped in 2020.

MORE folks came out to vote in Lindsey Graham's SENATE race yet left Trumps race blank?

Seriously?! So in an incredibly intense Presidential race folks in South Carolina suddenly came out in record numbers to vote in the SENATE race to elect Lindsey Graham? Coming out for Grahams race, but not Trumps, seems far-fetched.

It defies both logic & historical data.

But the numbers suggest Lindsey Graham became wildly popular■ From his last election he more than doubled his votes

2014: 672,941  
2020: 1,369,137  
An increase of 103%

Yet Trump only increased his votes by 20% since his last election■

2016: 1,155,389  
2020: 1,385,103

Again, a common element is the voting machine manufacturer ES&S.

South Carolina has a long history with ES&S. And the state just bought new ES&S equipment (the same models used in Kentucky). This despite a computer expert trying to point out the states problematic ES&S history.

## South Carolina Signs On

When South Carolina upgraded its machines, SMART Elections advisory board member and a University of South Carolina computer science professor, Duncan Buell, tried sharing his knowledge of the state's problematic history with ES&S.

Buell's said [concerns](#) arose after finding flaws with the code that led to votes being counted more than once, ignored or tallied incorrectly. After being scheduled to speak to the selection committee, Buell was bumped from the agenda.

South Carolina proceeded to purchase \$51 million worth of ES&S machines ahead of the 2020 election without hearing Buell's expert testimony.

It makes you wonder, would there have been an impact if South Carolina hadn't purchased new ES&S equipment?

Wouldn't it be interesting to look at a state who used ES&S for decades & switched to another type of voting machine in 2020?

Well we can. Consider the case of Georgia...

Many people don't realize that prior to Georgia's 2020 election they had a long term relationship with ES&S

At the time of the controversial 2018 gubernatorial race between Stacey Abrams & Brian Kemp (the man who at that time ran Georgia's elections) they used old ES&S machines.

The 2018 Georgia election resulted in multiple lawsuits. And they raised similar down-ballot questions to the ones I saw in KY & SC.

Of 3.9M+ votes cast, about 160,000 of them left the Lieutenant Governor race blank. That was 80,000 fewer votes than other down-ballot races.

The numbers suggest that folks voted for the Governor, then left the Lt Governor race blank & then voted in the other down-ballot races■

Neither logic or historic data supported these results but they couldn't dispute them since the paperless ES&S machines couldn't be audited.

And court documents revealed even more extraordinary details.

For example, a precinct had 7 voting machines.

On 6 of the machines Dems won every race.

On the 7th machine...Republicans won every race■

A statistician described this scenario as "less than one in one million"
