

We have an entire political party attempting to whitewash this attack as a "normal tourist visit."



When he finally issued a statement, it was criticizing his former VP Mike Pence for "not having the courage to do what he should have"—which of course in Trump's mind was disregarding the electoral college vote and simply declaring Trump the victor (a power the VP DOES NOT HAVE).

"Mike Pence didn't have the courage to do what should have been done to protect our Country and our Constitution, giving States a chance to certify a corrected set of facts, not the fraudulent or inaccurate ones which they were asked to previously certify. USA demands the truth!" Trump wrote at 2:24 p.m., as the mob was breaching the building.

He then followed this up with a video telling his army of cult terrorists "we love you. You're very special. Now go home. And go home in peace." (How many murderous terrorists are given the opportunity to simply 'go home in peace' after a deadly insurrection?)

Every person who has testified about their experience at the Capitol on Jan 6th has made 2 things unequivocally clear:


- 1.) THIS WAS DOMESTIC TERRORISM INCITED BY A REPUBLICAN LIE
