A shocking case of the Waqf Board claiming a property has come to light in Tamil Nadu, where an entire Hindu majority village has been declared as waqf property. Thiruchendurai village near Trichy has been designated as a waqf property by the Tamil Nadu Waqf Board. (2/17)

A person named Rajagopal attempted to sell his 1 acre 2 cents of land. When he arrived at the Registrar's office to get the sale of his land registered, he shockingly learnt that the land did not belong to him and instead belonged to the Waqf Board. (3/17)

"The Waqf Board owns the land on which you have come to register the deed. This contract cannot be registered, according to the Waqf Board's directive," the registrar stated. "You should obtain an NOC from the Waqf Board in Chennai," he further added. (4/17)

"Why do I need to obtain a no-objection certificate from the Waqf Board to sell my land which I purchased in 1992?" Rajagopal inquired in astonishment. (5/17)

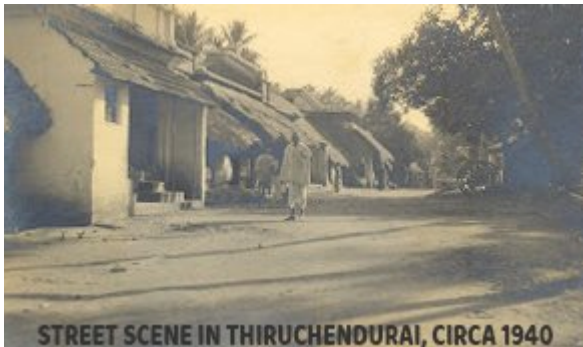
Showing a 250-page letter from Tamil Nadu Waqf Board to Rajagopal, the registrar said that any sale of land in Thiruchendurai village requires a no-objection certificate from the Waqf Board in Chennai. (6/17)

"The Waqf Board informed the Deeds Dept. by letter and documentation that the entire village is theirs. It has also been stated that individuals who come to register a deed for land in the village should obtain a no-objection certificate from them," the registrar said. (7/17)

When Rajagopal narrated the incident to the villagers, all of them were shocked to learn that their land is'nt theirs. They wondered how Waqf Board can claim ownership of the entire village when the villagers have all the necessary documents for their respective lands. (8/17)

When this subject was brought to the District Collector's attention by the villagers, he stated that the matter will be investigated and action will be taken after that. (9/17)

Trichy district BJP leader Allur Prakash said, "Thiruchendurai village, near Trichy, is an agricultural area dominated by Hindus. What is the Waqf Board's connection with Thiruchendurai Village?" (10/17)



Allur Prakash: The Manendiyavalli Sametha Chandrasekhara Swamy temple in this village is 1500 years old according to many documents and evidence. The temple holds 369 acres of property in and around Thiruchendurai village. Is this temple property also owned by Waqf Board? (11/17)



Allur Prakash: What is the basis for this? How can the Waqf Board proclaim without any fundamental evidence when the revenue records belong to individuals? (12/17)

Also, in 2021, the 'Minorities Welfare Department' had instructed the Inspector-General of Registration to not register documents alienating Waqf Board properties based on "NOCs" issued by the staff of Tamil Nadu Waqf Board.
