Today I decided to head up the Oldman to see what the coal companies have been getting up to. I forgot, however, that the forestry trunk road is closed at Dutch Creek each winter, ostensibly for wildlife protection. So I parked at the locked gate and started hiking. Evidently only the public is locked out; there was lots of signs of industrial traffic — logging and coal exploration — on a well-ploughed road. But the wildlife was certainly there. I saw tracks of a pack of wolves, a couple lynx, lots of coyotes, moose and deer and smaller creatures.

It's not all that rewarding to walk on a major road up a heavily-logged valley, but it was a lovely day: warm and calm and, at least for the first couple hours, sunny. There were several snowmobilers parked back at Dutch Creek and they had left tracks in the forest, but none came my way. In fact I saw nobody all day except the driver of a big truck that was hauling used pipe up the valley, apparently for Atrium's coal exploration roads.

Four kilometres in, I saw the first sign of new damage, way up on top of a mountain ridge that separates the upper Livingstone River and the north fork of the Oldman. A bulldozed road sneaked around the ridge top to a sandstone outcropping and a big gouge there showed recently exposed coal. I could see where the wind had been spraying coal dust all down the lee slope. But from the valley floor, most of the ridge top is invisible and it was clear from the amount of snow on the slope that I wasn't going to get there today.

Nine kilometres in, I found a new exploration road gouged into a previously intact slope with a temporary bridge and a big gate at the bottom. I ignored the no-trespassing sign the company had installed on our public land and punched my way through the hard-drifted snow to the bridge so I could photograph their signs. The road angles up and out of sight from there, perfectly laid out to funnel a few tonnes of eroded silt into the cutthroat trout stream at the base of the hill. I'll be back in spring to photograph that happening.

But I still had nine kilometres to hike back out, and the company had evidently stopped operations, at least at this site, until spring so there wasn't going to be much more to see. So I headed back down that once-idyllic valley, pausing to photograph a sign advising the public about how volunteers were planting willows in erosion sites along Hidden Creek. That's how we roll here in Alberta: the government allows logging companies and Australian coal miners to strip whole landscapes, and then volunteers arrive to try and bandage some tiny wounds. Because those volunteers, at least, care.

Am I bitter? Yeah, a little. Well, actually: a lot. I just spent half a day bearing witness to violence in a place I love. But it was encouraging to find at least that I was not alone. Someone else had been in there before me and had left a sticker on a road sign. It said "Save the Oldman River: Stop Crowsnest Mines."

Alberta still has good people. But unlike me and my mystery friend, most don't know how little time our last good places have before their coal is tortured out of them and they are left in ruins.

Another big truck passed me as I headed out.

It was hauling a massive track-hoe on a flatbed trailer up into our mountain headwaters, up where the coal is. Where it is meant to stay.

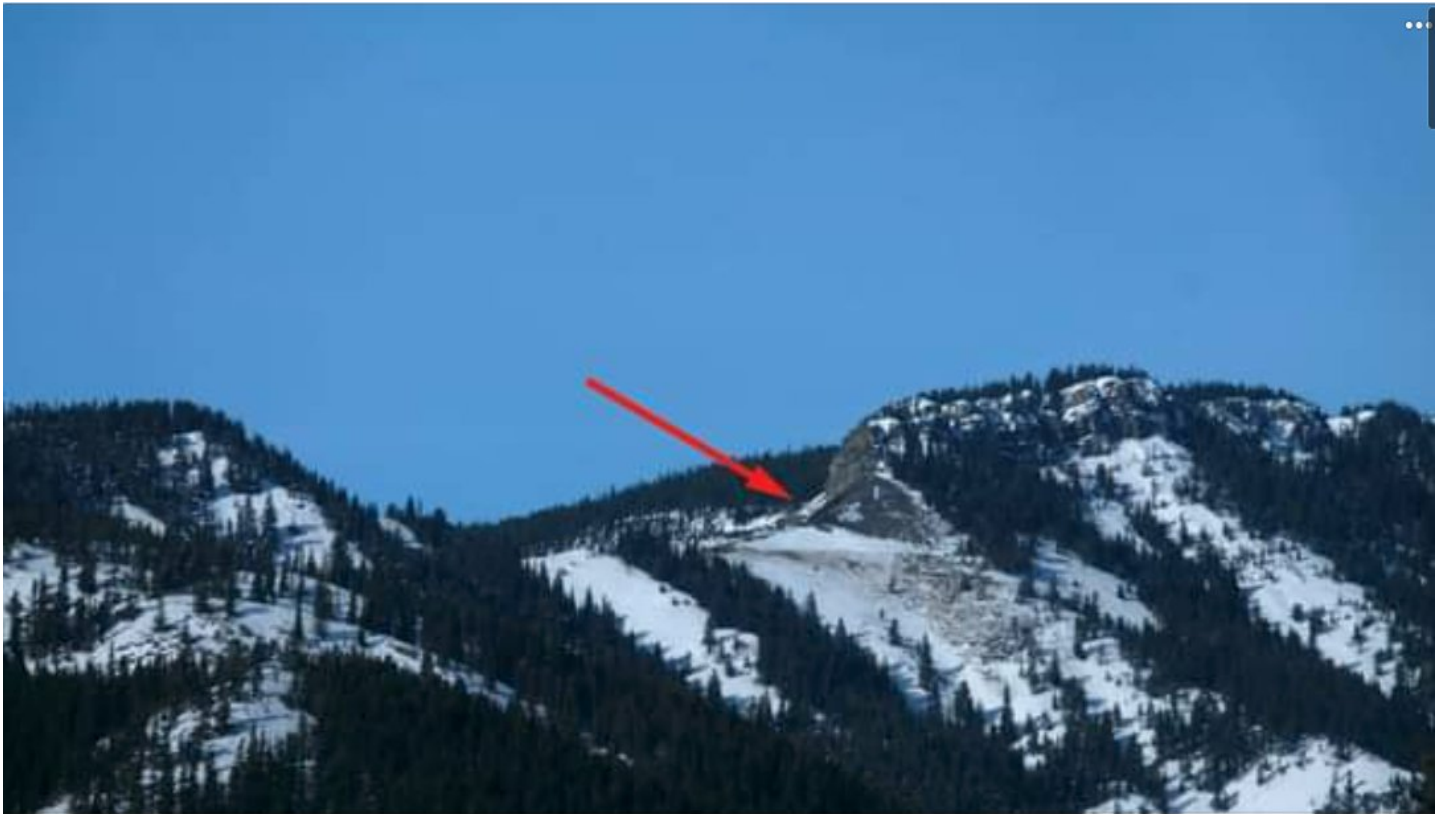

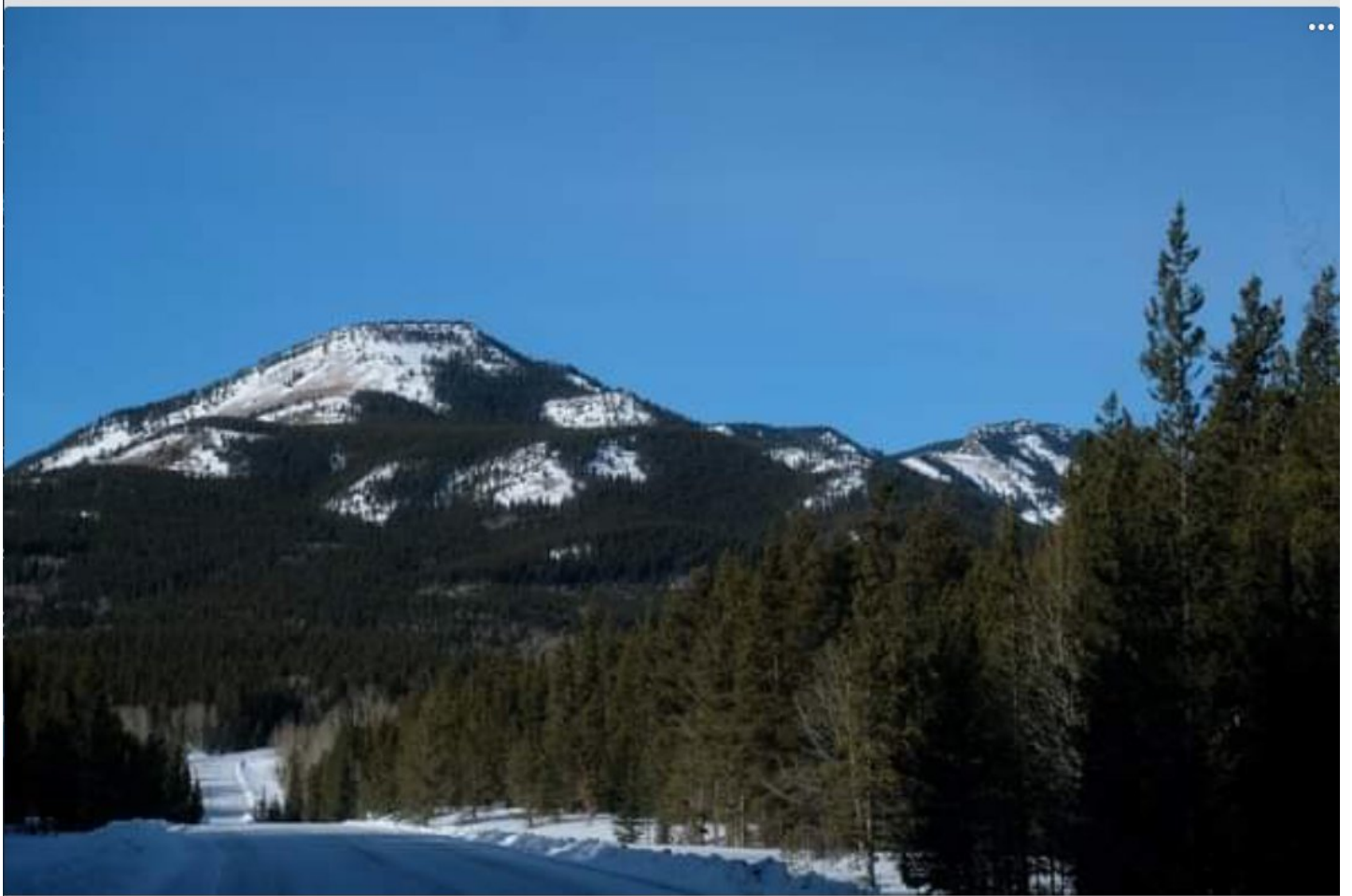

Hidden Creek Riparian Restoration Project

Hidden Creek is home to two of Alberta's most threatened native fish species, Westslope Cutthroat Trout, and Alberta's Provincial Fish, Bull Trout. The spawning habitats found in Hidden Creek are critically important to Bull Trout in the upper Oldman River system. A decline in the number of spawning Bull Trout in Hidden Creek in recent years may be due to decreased quality of spawning habitats. To address the issues facing this important tributary, the

Bull trout are also fish with a large head, olive-green to grey back, and silvery sides with pale pink to red spots. There are no black spots on the dorsal fin. There is a prominent white (or light) stripe on the side.

Bull Trout: "No Black Put it Back!"



Cutthroat trout have a bright red-orange streak in the top under the mouth. They also have small spots and black spots without halos on the sides. Westslope Cutthroat Trout are provincially and federally listed as a threatened species.

Cuttings of willow and poplar were harvested by volunteers and planted as live "wattle fences" to reduce erosion and sediment entering the creek.
