**Robert Sanford, the retired PA firefighter who has been charged in the DC riot, went to the Capitol following "the President's instructions," a complaining witness told the FBI.**

In a recorded interview that also occurred on January 12, 2021, the complainant told FBI Special Agents that SANFORD had told the complainant that SANFORD had travelled to Washington, D.C. on a bus with a group of people. The group had gone to the White House and listened to President Donald J. Trump's speech and then had followed the President's instructions and gone to the Capitol. The complainant indicated that SANFORD had claimed to have been on the Capitol grounds for about 10 minutes before "they" left. SANFORD did not mention to the complainant having thrown any objects, and SANFORD did not elaborate to the complainant about who "they" were. SANFORD acknowledged to the complainant that the photograph of the man in the CFD hat was, in fact, SANFORD. When shown screen captures from Video #2, the complainant identified the Subject in the screen captures as SANFORD.

Peter Harding, a Buffalo area man, has been charged by feds in the Capitol riot. The FBI notes that he was captured in social media photo lighting fire to media camera equipment outside building before entering.



The FBI says Kevin Lyons was "evasive" at first about being inside the Capitol. Then, when agents showed him an Instagram pic he'd taken & posted of Nancy Pelosi's office, he caved. "Wow, you're pretty good," he said. "That was only up for an hour."

15. LYONS acknowledged that he was in D.C. on Jan 6, 2021, but was evasive about whether he entered the Capitol Building. LYONS stated that he "100% guaranteed, without incriminating himself" that he saw nothing being damaged. He further stated that in a dream he had, he saw a lot of banging on doors, paper being throwing about, and a mob of people. According to LYONS, in the dream, people really didn't have much choice of where they were going because of the mob. LYONS advised that if he were inside, he was inside for approximately 45 minutes.

16. LYONS was shown the photo referenced above that read "Speaker of the House Nancy Pelosi" at which time LYONS stated, "wow you are pretty good that was up for only an hour." Law enforcement understood LYONS' statement to be expressing surprise that law enforcement officers had found and observed this photograph on his Instagram account because it had only been posted on his account for one hour before it was removed. LYONS then stated that he can't guarantee that he posted it.

Kevin Seefried told the feds that he and his son Hunter went to DC on Jan. 6 from their home in Delaware "to hear President Trump speak."

They brought along the Confederate battle flag from the house "where it is usually displayed outside."

On January 12, 2021, both Kevin Seefried and Hunter Seefried participated in voluntary and separate interviews with the FBI. Both defendants confirmed their participation in the events at the Capitol as discussed herein. Kevin Seefried also explained that he brought the Confederate Battle flag seen in Exhibit A to the District of Columbia from his home in Delaware where it is usually displayed outside. Defendant Kevin Seefried told law enforcement that he had traveled with his family from Delaware to the District of Columbia to hear President Trump speak and that he and Hunter Seefried participated in a march from the White House to the Capitol led by an individual with a bull horn.

The feds were able to find & charge Jenny Cudd of Texas in part b/c she posted a FB video of her incursion on the Capitol. "We did break down Nancy Pelosi's office door & somebody stole her gavel..." Cudd said. "...Hell yes I am proud of my actions."

During the course of the Facebook video, Jenny Cudd made the following statements indicating her admission of entering the U.S. Capitol: "We were on the south lawn listening to the President and before the speech was over we started to head up to the Capitol." Your affiant has identified this was location of a speech given by U.S. President Donald Trump on January 6<sup>th</sup> in Washington D.C. Jenny Cudd further stated, "we just pushed, pushed, and pushed, and yelled go and yelled charge. We just pushed and pushed, and we got it." Your affiant has identified this was a reference to the large crowd of individuals who forced their way inside the U.S. Capitol. Jenny Cudd stated on the video, "...and we got in. We got up to the top of the Capitol and there was a door open and we went inside." Jenny Cudd also stated in the video, the following indicating her presence inside the U.S. Capitol, "We did break down the Nancy Pelosi's office door and somebody stole her gavel and took a picture sitting in the chair flipping off the camera." Later in the video recording, she further stated her presence inside the U.S. Capitol, "They had to evacuate it before we charged the Capitol." Jenny Cudd is referring to the members of Congress and the U.S. Senate evacuating the House Chambers and the Senate Floor prior to the forced entry of demonstrators. Jenny Cudd also stated the following during the video, "I stood outside of the Capitol and I will send photos of that too." In addition, she added the following recorded statement, "...fuck yes, I am proud of my actions, I fucking charged the Capitol today with patriots today. Hell, yes I am proud of my actions."

A bail hearing is about to begin in the case of Cleveland Meredith.

Meredith has been charged w/traveling to DC w/an assault rifle, a pistol painted like a US flag and armor piercing rounds. He's also accused of threatening to kill Nancy Pelosi & Mayor Muriel Bowser of DC.

The govt starts the hearing by arguing that the "interstate communication of threats" is a crime of violence and so Meredith should be detained.

Meredith's lawyer counters that's incorrect under case law.

Judge Michael Harvey agrees with the government: sending text messages conveying threats against people is a crime of violence.
