1. Julian #Assange #BailAssangeUK US counsel opposes bail: "cannot be trusted to surrender"

2. US counsel refers to Julian #Assange and "others at <u>@wikileaks</u> "*orchestrating* <u>@snowden</u>' escape as a legal ground to oppose #BailAssangeUK

3. Tremendously interesting to see how US counsel just confirmed that <u>@wikileaks</u> original plans was to help <u>@snowden</u> to get protection in #LatinAmerica

9. JA counsel, Fitzgerald says main defence's legal ground to apply for #BailAssangeUK is the physical and mental health assessment by medical experts. Fitzgerald mentions #LauriLove. let me say thank you to the unsung hero of LauriLove's victory: <u>@auerfeld</u>

10. JA counsel Fitzgerald: factors for "overwhelming case for granting #BailAssangeUK": mental health (as consistently acknowledge by judge Baraitser's judgement): depression, Asperger syndrome +Covid risk. Living with his partner @StellaMoris1 and their children will protect

11. JA counsel Fitzgerald: is he remains in #Belmarsh with Covid and visits suspended it will be "life threatening"

12. Judge Baraitser: Mr #Assange was a *fugitive* from UK justice

13. Judge Baraitser: US has already lodged its appeal

14. Judge Baraitser: detention in Belmarsh NOT comparable to detention in US when it comes to support for mental and physical conditions

15. Judge Baraitser denied bail! #BailAssangeUK
