Three bills on deck today... so might be a while before HB 1329. Will live-tweet out ze action as able.

But we will have a real hearing with real testimony & real sunlight as we work to build back better.

We also have HB 1180, a weak @WaHouseGOP #opengov bill with a lot of testimony to come also. Bill doesn't go far enough as I'll explain. Basically no online public comment option.

But enough about weak bills. HB 1180 won't go anywhere.

More worried about the concern trolling to amend and likely weaken HB 1329. #waleg has way too many lobbyists who don't work for the people but for the government bench as you can see below.

With that, the hearing has started and thankfully my [@zoom\\_us](#) app is working.

HB 1180 & HB 1329 hearing starts now... going to be a bit complex. Good my speeches align with Rep. Pollet's request for general principles, then notes.

Now, Rep. Kraft...

Now Rep. Kraft is speaking about adapting to new format. Keeps using the word format.

"Took a look at the overall process of public meetings".

Wants to ensure public participation.

Rep. Kraft worries about viewability and talks about the (limited) options of HB 1180. Notes her bill allows folks to have staff read in comments.

(JOE NOTE: As I recall [@MyCommTrans](#) tried this in March and it got to be a bit much.)

Rep. Kraft worries about how the public wasn't heard. Says the bill will make the bill transparent & accountable to the public & participation.

(JOE NOTE: This doesn't go far enough.)

Now Rep. Pollet asks Rep. Kraft if the bill allows for a time limit on public comment... worried about testimony being read out loud and denying the ability to set a time limit. Rep. Kraft notes that the time limit is OK.

Another Q from Rep. Goehner on remote access.

Rep. Kraft - who is breaking up - "will take a further look at that".

First Q and follow-up by Rep. Goehner is about issues of emergency. "Just thinking about some of the natural disasters" our state could have.

(JOE NOTE: I think he means volcanic eruptions, floods or earthquakes.)

More healthy discussion about notice. HB 1056 which addresses this now being brought up.

Finally HB 1180 testimony.

Don Land, Gary Wilson & Jennifer ?

Now talking about drag queens story hour and how resisting that becomes a public meeting issue.

I'm going to get a drink of water.

Now a good speech by Gary Wilson. Worried about how public input is being disconnected.

Gary is making a good case to enshrine public comments as a RIGHT in the OPMA.

Gary also is open to removing the emergency clause in HB 1180.

Now Jennifer Heine-Withee is speaking. "We are the ones who voted" the electeds into office. Demands listening.

(JOE NOTE: I can assure her that HB 1329 will remind government officials of this.)

Good question to me from Rep. Pollet where I got to explain the problems for transit-dependent folks to access the meeting.
