Hawley Statement On Objecting During Electoral College Certification Process

"Following both the 2004 and 2016 elections, Democrats in Congress objected during certification of electoral votes in order to raise concerns about election integrity. 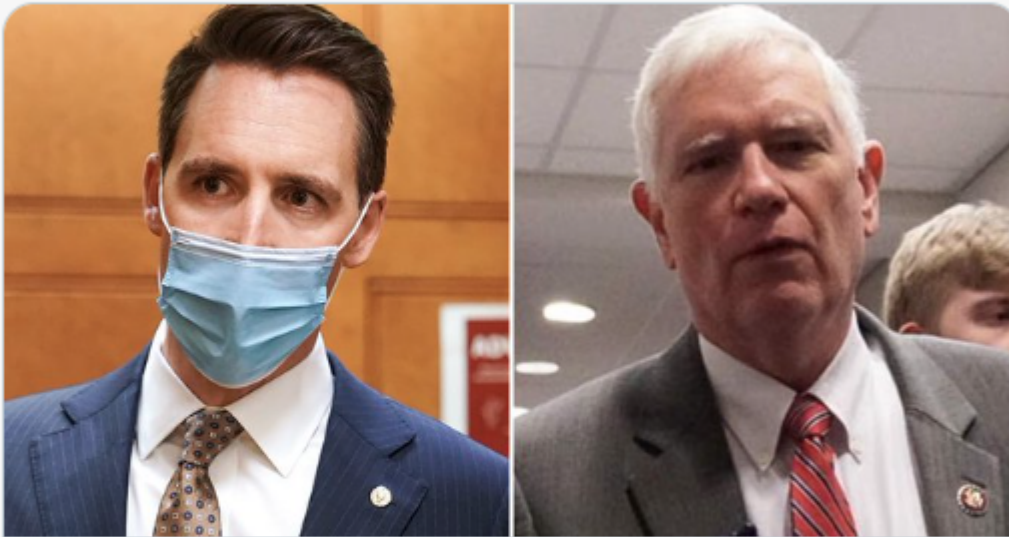
