**FOR OFFENSES CHARGED** in the United States District Court for the Southern District of New York in an indictment (Docket No. 20-cr-412) charging violations of Sections 981(a)(1)(C), 1349, 1956(h), and 1957(a), Title 18, and 2461(c), Title 28, United States Code.

**FOR ANY OTHER OFFENSES** under Chapter 95 of Title 18, United States Code that might arise, or be charged, in connection with the offenses alleged in the above-listed indictment (Docket No. 20-cr-412), in the United States District Court for the Southern District of New York, or any other federal jurisdiction.

Here's Elliot Broidy, a Trump fund-raiser who admitted to a role in a covert campaign to influence the administration on behalf of Chinese and Malaysian interests.

**FOR HIS CONVICTION** in the United States District Court for the District of Columbia on an information (Docket No. 1:20cr210) charging violations of Sections 371 and 981(a)(1)(C), Title 18, and 2461(c), Title 28, United States Code, for which he pleaded guilty on October 20, 2020, and for which sentencing is not yet scheduled.

**FOR THE OFFENSES** alleged in a complaint and affidavit in support of arrest warrant (Docket No. 20-MJ-990) in violation of Sections 2261A(2)(B) and 2261(b)(5), Title 18, United States Code, in the United States District Court for the Eastern District of New York.

Here's Aviem Sella, an Israeli who had been a fugitive from 1987 espionage and subversive activities charges related to recruiting a spy against the United States, Jonathan Pollard. (He was never extradited and pardoning him was a favor to Netanyahu.)

**FOR OFFENSES CHARGED** in the United States District Court for the District of Columbia in an indictment (Docket No. 1:87cr73) charging violations of Sections 2(b), 794(a), and 794(c), Title 18, and Section 783(c), Title 50, United States Code.

**FOR THE OFFENSES** alleged in an indictment (Docket No. 20-CR-111) in violations of Sections 371, 1955, and 1956, Title 18, United States Code, in the United States District Court for the Northern District of Illinois.

Here's Robert Zangrillo, a Miami investor who had been one of the wealthy parents charged in the Operation Varsity Blues college admissions scandal.

**A FULL AND UNCONDITIONAL PARDON**

**FOR OFFENSES CHARGED** in the United States District Court for the District of Massachusetts in a fourth superseding indictment (Docket No. 19-10080-NMG) charging violations of Sections 2, 371, 981(a)(1)(C), 982(a)(1), 1343, 1346, 1349, and 1956(h), Title 18, and Section 2461(c), Title 28, United States Code.

A common theme about these, starting at the top of this thread with Steve Bannon (who was charged with defrauding donors to the "Build the Wall" campaign <https://t.co/wvDo0m2ryv>) is none had served any prison time. A few were awaiting sentencing; most were not yet even tried.

It is good that the Justice Department has made publicly available the official scope and limits of what Trump let these people off for, rather than just the vague and generic hand wave of the "master warrant" certificate. /end
